

# **JANET HUMPHREY MEMORIAL FOURSOMES**

## **Conditions of Entry**

- 1 Entries from each club are not limited however if the field exceeds the capacity of the relevant course spaces will be equally apportioned across all clubs.
- 2 Entries will only be accepted upon payment of entry fee.
- 3 Refunds will be available until entries close.
- 4 After entries close refunds will only be made at the discretion of the Match Committee of the Southern Golf Group.
- 5 Entries will not be accepted after the closing date but a replacement may be made.
- 6 A light lunch will be provided and included in the entry fee.
- 7 **Entry Fees - \$40 per pair plus lunch (say \$15 per person), that is  $\$40 + 2 \times \$15 = \$70$ . This is to be paid directly to the hosting club when submitting entry form. Note the cost of lunch may vary between hosting clubs.**

## **Conditions of Competition**

- 1 This event is conducted under the auspices of Golf Australia Inc, the Southern Golf Group and under the Rules of the "R & A Golf Club of St. Andrews" and the local rules of the host club.
- 2 The Match Committee of the Southern Golf Group will be the arbiter of any disputes or matters arising from the event.
- 3 Only women members of Golf Clubs affiliated with the Southern Golf Group are eligible to enter.
- 4 Players must have a Golf Australia handicap and be able to verify it if requested.
- 5 In the event of a tie in this event the tie will be determined as follows:
- 6 The best score for the last 9 holes on the card shall be used; if there is still a tie the last 6 holes or if still tied the last 3 holes. If a tie still persists then hole by hole from the 18th.
- 7 To promote participation in this event motorized transport may be used.
- 8 Play will be in groups of four (i.e. two pairs).
- 9 The Host Club may choose one of the following: to start all players off the 1<sup>st</sup> tee; or to start players off both the 1<sup>st</sup> and 10<sup>th</sup> tees; or a shot gun start.
- 10 In all cases, players must report to the starter no later than 30 minutes before the start of play.
- 11 Trophies will be presented on the day of play.
- 12 Prizes –  
40% of Entry Fees is to be distributed as prizes (Prize Pool).

Winning pair to receive 37.5% of prize pool  
2<sup>nd</sup> pair to receive 25% of prize pool  
3<sup>rd</sup> pair to receive 12.5% of prize pool  
Plus a ball run down for 25% of prize pool

## **Hosting Club**

The hosting club:

- may conduct a raffle and retain proceeds
- retains all net proceeds after deduction of all expenses from entry fees.
- Must submit a report detailing number of competitors, total entry fees collected, detail of expenses paid out, including prizes, and net revenue retained by the club.
